A BRIEF HISTORY OF THE SOUTHWESTERN FASTENER ASSOCIATION

The Association, originally known as the Texas Fastener Association, was founded on the basic principal that there was a need in the fastener market to exchange ideas and experiences on successful business practices and techniques related to our market. The Association held its initial formative meeting at the La Baron Hotel in Dallas on November 21, 1974, with 27 people, representing 20 companies.

From this embryonic stage came the first formal meeting held in January 1975, with 67 persons, representing 50 companies, in attendance. At this meeting, the name was formerly changed to the Southwestern Fastener Association. Our membership consists of distributors, manufacturers, importers, technology, agents, and processors.
